## R.M. of ELLICE – ARCHIE BY-LAW# 12-2019 GENERAL RESERVE FUND BY-LAW

**BEING** a by-law of the Rural Municipality of Ellice - Archie to provide for the establishment of a General Reserve Fund.

**WHEREAS,** under The Municipal Amalgamation Act, C.C.S.M. c M235, the Province of Manitoba, by Regulation 120/2014, has established the municipality known as the Rural Municipality of Ellice – Archie, which amalgamated the former Rural Municipality of Archie, the Rural Municipality of Ellice and the Village of St. Lazare;

AND WHEREAS, Section 168(1) of The Municipal Act, S.M. 1996, c58 provides that a Municipality may by by-law establish reserve funds for any general, or specific purpose;

**AND WHEREAS**, the Council of the Rural Municipality of Ellice – Archie deems it necessary to create a General Reserve Fund;

**NOW THEREFORE BE IT RESOLVED** that the Council of the Rural Municipality of Ellice – Archie, in session duly assembled, does hereby enact as follows:

- 1. **THAT** a Reserve Fund be created to be known as the "General Reserve Fund".
- THAT an appropriation shall be made to the General Reserve Fund at the discretion
  of Council by setting aside any surplus monies of the Municipality not presently
  required, or by levying a special rate over and above the current requirements of
  the Municipality.
- 3. **THAT** the Municipality shall maintain, within its books, a separate financial account designating the purpose for which the fund was created and showing at all times the state of the General Reserve Fund created hereby.
- 4. **THAT** the proceeds of the General Reserve Fund may be invested or re-invested in accordance with the provisions of Part 6, Division 4 of The Municipal Act.
- 5. **THAT** the former Rural Municipality of Archie's By-Law No. 1009 now be repealed with any surplus balance of monies for the same Rural Municipality of Archie's *General Reserve Fund* at the end of the 2014 fiscal year, to be transferred to this newly created General Reserve Fund of the Rural Municipality of Ellice Archie.
- 6. **THAT** the former Rural Municipality of Ellice's By-Law No. 15-66 now be repealed with any surplus balance of monies for the same Rural Municipality of Ellice's *General Reserve Fund* at the end of the 2014 fiscal year, to be transferred to this newly created General Reserve Fund of the Rural Municipality of Ellice Archie.
- 7. **THAT** the former Rural Municipality of Ellice's By-Law No. 3-2004 now be repealed with any surplus balance of monies for the same Rural Municipality of Ellice's *Road Construction Reserve Fund* at the end of the 2014 fiscal year, to be transferred to this newly created General Reserve Fund of the Rural Municipality of Ellice Archie
- 8. **THAT** the former Village of St. Lazare's By-Law No. 6-69 now be repealed with any surplus balance of monies for the same Village of St. Lazare's *General Reserve Fund* at the end of the 2014 fiscal year, to be transferred to this newly created General Reserve Fund of the Rural Municipality of Ellice Archie
