

**R.M. of ELLICE – ARCHIE
SPECIAL SERVICE BY-LAW #06-2020
FOR CURBSIDE PICKUP IN MCAULEY
WASTE & RECYCLABLE MATERIAL**

Being a By-Law of the Rural Municipality of Ellice-Archie to establish a rate for Special Service Proposal for curbside collection of waste and recyclable material on all residential properties, excluding vacant lots within the urban area of McAuley for the years 2021 to 2025, inclusive;

WHEREAS section 312 of The Municipal Act provides in part as follows:

If approved by by-law, a municipality may provide, as a special service to all or part of the municipality,
(e) the collection and transportation of waste or recyclable materials;

AND WHEREAS subsection 320(1) of The Municipal Act provides as follows:

Subject to subsection (2) to (6) and subsection 321(4), a Council may by by-law

- (a) Approve the local improvement or special service as set out in the plan or proposal; and
- (b) Authorize the municipality to impose taxes as set out in the plan or proposal.



AND WHEREAS, the Council of the Rural Municipality of Ellice – Archie has prepared Special Service Plan #06-2020 to establish a rate for the curbside collection of waste and recyclable material in the urban area of McAuley pursuant to Part 10 of The Municipal Act;

AND WHEREAS the requirements are prescribed in Sections 318, 319 and 320 of The Municipal Act have been complied with;

NOW THEREFORE the Council of the Rural Municipality of Ellice – Archie enacts as follows:

1. That pursuant to subsection 320(1) of The Municipal Act, the R.M. of Ellice – Archie approves Special Service Plan #06-2020 attached hereto as Schedule “A”.
2. That the Rural Municipality of Ellice – Archie shall implement a special per parcel rate upon all rateable properties, excluding vacant lots, within the urban area of McAuley as hereby described in Schedule “B” hereto in each of the years 2021 to 2025 (5 years).

DONE AND PASSED as a by-law of The Rural Municipality of Ellice - Archie at McAuley in the Province of Manitoba this 11th day of December, 2020.

1. DESCRIPTION OF THE SPECIAL SERVICE

The Special Service Plan proposed herein involves the curbside waste and recyclable material pickup to all residential properties within the urban area of McAuley. (Vacant lots excluded)

2. AREA OF THE MUNICIPALITY TO BE LEVIED UNDER SPECIAL SERVICE TAX

The local improvement district under this proposal will be all residential properties with a residence within Section 10 Township 15 Range 29 WPM known as the urban area of McAuley. All vacant lots are excluded.

3. POTENTIAL TAXPAYERS UNDER THE PLAN

Potential taxpayers are all property owners with residential properties within the urban area of McAuley, as listed as Schedule “B” attached hereto.

4. METHOD AND RATE OF CALCULATING THE SPECIAL SERVICE TAX

The Special Service Tax to be charged under this proposal are to be calculated on an amount per parcel of land.

Costs for years 2021:

The rate will be: **\$167.27 per property**, as listed in Schedule “B” attached hereto.

Total	\$9,700

The rate will be: **\$176.36 per property**, as listed in Schedule “B” attached hereto.

Costs for years 2025:

Weekly Waste Collection (RM Employees)	\$4,000
Biweekly Recycling Collection (Loraas Disposal)	<u>\$6,000</u>
Total	\$10,000

The rate will be: **\$181.82 per property**, as listed in Schedule “B” attached hereto.

5. ESTIMATED COST OF SPECIAL SERVICE

Curbside waste and recyclable material in the urban area of McAuley is:

- \$9,200 annually for 2021
- \$9,300 annually for 2022
- \$9,500 annually for 2023
- \$9,700 annually for 2024
- \$10,000 annually for 2025

6. FUNDS GENERATED BY THIS SPECIAL SERVICE TAX

The Special Service Tax will raise:

- \$9,199.85 annually for 2021
- \$9,299.95 annually for 2022
