AND WHEREAS the ability for our volunteer fire departments to perform safely and to the best of their ability, they require appropriate, well functioning equipment;

THEREFORE BE IT RESOLVED THAT the council of the RM of Ellice – Archie authorizes the CAO to submit an application to the Manitoba GRO program to assist with the purchase of two newer pumper fire truck apparatuses for our volunteer fire departments to replace the current 1993 and 2004 models in use.
